**FURTHER RESOLVED:** to contact Eddie West at Shropshire Council to inform him that our Place Plan is incorrect and ask them to put all the original projects plus the additions that had been asked for back in and then this committee will review the projects at a later date.

### PI-09/23/07 Neighbourhood Plan.

(a, b & c) Cllr Elner had reached out to other Town and Parish Councils to ask about their experiences of developing a plan and how they have benefitted since. The feedback received from Much Wenlock whose plan has been adopted was that it is a good idea and that they have benefitted from additional Neighbourhood fund monies. Broseley and Pontesbury are currently developing their plans and have been happy with the experience so far.

Members discussed the Neighbourhood Planning Policy that had been circulated and considered whether Ellesmere would benefit from developing a plan.

It was agreed by all members for ClIr Jones to investigate the process in detail together with associated costs and he will deliver a paper to the committee for further consideration at their next meeting.

## PI-09/23/08 Highways & Parking issues in Ellesmere.

The meeting closed at 6.57pm.

The Clerk informed members that she is still chasing a response from Shropshire Council in relation to the parking issues and highways issues identified by them in the street plan.
